*TO: All Vendors/Exhibitors/and Participants at the 2010 I-ACT Convention*

The I-ACT Convention for 2010 will be held from June 16 - June 19, 2010 in St. Petersburg, FL. Pre-Convention Meetings start on Tuesday, June 15, 2010. Vendor setup will be on June 16, 2010 with teardown on Sunday morning, June 20, 2010.

Room rates for this convention are only \$99.00 so this should be a very large convention and will probably meet or exceed the attendance of the 2009 convention.

Enclosed is a Vendor Registration form, and a flyer about advertising in our convention brochure. As always, there is limited space for this convention, so our Vendor Booths (size 8'x10') will go on a first come, first served basis. We have space for approximately 35 booths. Make your reservations early. Reservations will only be confirmed when the money is received. We will use pipe and drape to ensure each vendor gets the appropriate space.

Should you wish to advertise in the 2010 Convention Program, you must supply this office with your ad no later than May 1, 2010. The size and style of ad are indicated in the flyer on the back.

Remember, it is the responsibility of the Vendor to arrange for electricity with the pipe and drape company.

In order to ensure that I-ACT continues to comply with all Federal requirements and to assist us so we do not place vendors with similar merchandise next to each other, we have provided a form so you may indicate the items you will be advertising/marketing at this convention. Please make this list as detailed as possible, items not on this sheet will not be allowed to be displayed at the 2010 I-ACT Convention. **If you are going to be displaying colon hydrotherapy equipment, you must provide a current 510k for each type of equipment displayed. If we do not receive copies of your 510 k with the vendor registration form, we cannot allow that equipment to be displayed.**

3. Vendors must maintain integrity of service.
4. Vendors are expected to practise fair trade at all times.
5. Vendors will only display and promote products specific to their company and will not accept any subsidiary products to be represented or promoted at their booth.
6. Only vendors registered at the I-ACT convention exhibition are permitted to promote and sell their products and services. Anyone found selling items without being a vendor will be barred from future participation at future I-ACT conventions.
7. I-ACT reserves the right to accept vendors promoting and selling similar products, eg. Multilevel marketing products at the convention. However, all such vendors will be informed of the presence of the other party/parties.
8. I-ACT reserves the right of decision on acceptance of vendors participation at exhibitions. Decisions of acceptance or refusal of a vendor is final and does not warrant any explanation.
9. No party representing the vendor shall solicit for business beyond the boundaries of their vendor's space.
10. Complaints relating to other vendors or activities by non-registered vendors must be directed to the Office. Appropriate actions will be taken at discretion of the I-ACT Board according to the guidelines of I-ACT.
